

20 Year Limited Warranty

Bestdeck LLC (hereinafter "Bestdeck") warrants to the original consumer purchaser that, for a period of twenty (20) years from the date of original consumer purchase, under normal use and service conditions, Bestdeck products shall not check, split, splinter, peel, rot or suffer structural damage from termites, insects or fungal decay. If the product fails to conform to this warranty, Bestdeck in its sole discretion shall either replace the defective product or refund the portion of the purchase price paid by the original consumer purchaser for such defective product. The warranty will be prorated according to the schedule to the right. In no event shall Bestdeck be liable for labor, installation, freight, taxes or any other charge related to defective product. This warranty is not transferable.

This warranty does not apply to Bestdeck products used in commercial or industrial structures. This is a residential warranty only. Bestdeck is not responsible for any misapplication of its products, intentional damage or damage caused from misuse or abuse of its products.

Some states do not permit limitations on the duration of implied warranties or exclusions or limitations of incidental or consequential damages. This warranty gives you specific legal rights. You may have other rights, which vary from state to state.

Making a claim: Purchaser must submit his/her claim in writing to us within the warranty period and within a thirty (30) day period after the alleged defect is discovered. The claim must be submitted together with the warranty registration, the original purchase invoice indicating date of purchase, picture of the defective Bestdeck product, and a detailed written description.
